

## DIRECTIONS FOR USE

When mixed, fill spray tank half full with water and add the required amount of Organic-N while continuing to fill tank with water. Continue agitation through the spray operation. See Precautions. Always agitate drum contents before use.

## APPLICATION RATES

### Horticultural Crops:

Minimum dilution 1 : 100 with water.

(1: 150 for Almonds, Avocados, Citrus)

Foliar Spray: 2 - 5L/ha; repeat as required.

Irrigation: 5 - 10L/ha; repeat as required.

### Broad-acre Crops and Pastures:

Minimum dilution 1 : 30 with water.

Foliar Spray: 2-5L/ha; repeat as required.

Each farmer's situation and processes and practices may differ and therefore necessitate corrections to ensure optimum results. Adjust rates according to production levels. Repeat as required.

Always test for compatibility and crop suitability prior to use. Seek advice for rates suited to your crop.

## TYPICAL ANALYSIS

Nitrogen 10% w/v as amino acids.

With fulvic acid 23% w/v, trace elements (Ca, Mg, Zn, Fe), Organic Carbon 37.5% w/v.

## CLEAN UP PROCEDURE

Use all mixture in spray and irrigation tanks; purge tanks and lines with clean water; flush irrigation lines. Do not return mix to original drums.

## STORAGE

Store in original container away from direct sunlight. Do not store in diluted form. Do not store at temperatures exceeding 40°C.
