DIRECTIONS FOR USE

Add to full fertigation tank under agitation. Ensure tank is under constant agitation during use.

Always agitate drum contents before use.

APPLICATION RATES

Horticulture:

Pre-plant (injection)* : 5L/ha

Via irrigation* : 5L/ha

Foliar: 100-300mL/100L

Minimum dilution rate: 1: 50 Uptake Ca to water

May be used in Organics as a soil amendment if soil deficiency of boron is documented by testing.

* Note: for USA NOP compliance Uptake Ca restricted to use as a foliar spray to treat a physiological disorder associated with Calcium uptake.

CLEAN UP PROCEDURE

Use all mixture in irrigation tanks; purge tanks and lines with clean water; flush irrigation lines. Do not return mix to original drums.

COMPATIBILITY

Physically compatible with a wide range of commonly used products. Always mix a small quantity (jar test) and check for physical compatibility before combining with other ingredients.
